1. In the event that the well pump breaks down.

 - b. Contractor will be contacted to perform the needed repairs.
 - c. A reading of all water meters will be completed.
 - d. Members will be notified to conserve water.
 - e. Members will be charged IAW their usage the actual cost of the water. The cost of delivery per gallon.
 - f. There will be established times for turning on and off the water until the well is repaired. This will need to be done in order to protect the boost pumps.
 - g. Members should have a backup plan for obtaining drinking water to conserve water.

Open Issues

1. Registering to vote. Forms have been mailed, emailed, and dropped off at members addresses. We had had limited response. This is a requirement in order to vote on any issues, such as water rates, elections, etc.
2. Property liens. Liens are being placed on the properties of landowners that refuse to pay their water bills.
3. Tapping into the water line ahead of the meter without authorization of the Wild Flower Board is against the bylaws and the law. Any violations will be addressed in a timely manner.
4. Water lost for 2022. We lost a total of 553,571 gallons of water of water, that is equal to \$2767.86 in lost revenue. This is unacceptable. We as a Co-op need to find out what is going on. I have been looking for water leaks and have found none.
5. Grant for the upgrade of the well and water lines is still in the works.

Approval of Agenda

The agenda was unanimously approved as distributed.

Open Issues

1. Water loss for February 25%. We all need to be on the lookout for leaks etc. I've been going around looking for leaks. Water meter replacement needs to be a top priority.
2. A developer is talking about purchasing the 10-acre parcel behind the Speedway market and splitting it up to two acre parcels. I told them that they would have to pay for the extension to the four-inch water line and any fees associated with it. Provide easements for the reading of meters. They agreed to give a ¼ acre easement for a second possible well sight.
3. We had to put a lien on a property for non-payment of water bills. \$600 plus.
4. We have been testing the meters and finding they are failing. Reading low.
5. Researching for Grant for a future second well.
6. Working on status of grant for the engineering requirements for well and water line upgrades.
7. Set-up meeting for the members. We need participation, only one individual beside the board showed up.

WILD FLOWER WATER CO-OP FEE SCHEDULE

Monthly flat rate/service charge **\$20.00**

Cost per gallon **0.005**

Membership Fee to reconnect service for established residence with existing operational meter and change of ownership **\$150.00 plus \$100.00 for maintenance fund. Total:(\$250.00) Note: If a meter is required to be moved or replaced an additional \$500.00 will be accessed.**

New installations one-time membership fee **\$500.00. Plus \$100.00 for maintenance fund plus and any cost associated with tapping the main line bringing water to the property line. Wild Flower Water Co-op will provide the water meter, meter box, and curb stop at no additional cost.**

RENTERS:

To establish service **\$150.00 plus \$150.00 refundable deposit. Total: \$300.00**

Late fees **\$30.00** (payment is due and must be received by the 22nd of each month). If the 22nd falls on a Saturday or Sunday it must be received by the 25th.

Past due accounts that service has been severed. All past due amounts paid in full, and a **\$300.00** refundable deposit must be posted prior to the service being turned on.

Miscellaneous expenses:

Cleaning in and around meter boxes **\$35.00**
