CEDAR GROVE WATER, INC

Dear Cedar Grove Water Customers:

At its Open Meeting on August 6, 2019, the Arizona Corporation Commission (Commission) approved the following rates and charges requested by the Cedar Grove Water, Inc. (Cedar Grove or Company) in its application filed on June 16, 2018. Per Decision No. 77368, the rates and charges herein will be effective for all service provided on and after the first billing cycle that commences after September 20, 2019. The recent approval will increase the monthly bill for an average residential customer with a 5/8" x 3/4" meter and median usage of 2,383 gallons per month from \$36.38 to \$42.03, an increase of \$5.66 per month or 15.6 percent.

The Commission also approved Cedar Grove's request to incur long-term financing in an amount not to exceed \$445,232 and a loan surcharge to fund the debt payment. The loan will be used to fund the construction of two transmission interconnections- one 2,200-foot and the other 3,500-foot- that will link the Company's main system to satellite. The loan will also finance the deployment of a Supervisory Control and Data Acquisition ("SCADA") system and replace the Company's 488 meters with radio reads. The estimated loan surcharge of \$9.36, is expected to go into effect in September 2019.
