Discussion of Capital Projects

- Wells/pumps, 1-2 per year at \$2,500-6,000.00. Our wells are past 10-year expectancy. Recommend \$50,000.00 reserve per year.
- System repairs, main line repairs. \$10-12,000.00 plan on 1-3 per year, budget \$30.000.00 per year.
- Storage tanks, in good condition, contract with Suez for maintenance. Full replacement possibly by 2035 @ \$2.00 per gallon. SUM will provide the Suez contract for the board.
- Chlorination system is liquid injection, 2 pumps are new last year so plan on \$1,500.00 per year for maintenance. Blending station and Manzanita well.

Manzanita Filter Upgrade

- Working great, head pressure is down, double filters.
- Not planning on doing a pressure switch. Daily check on filters.
- 1 Micron filter, not tried yet/research/increased cost/ consider adding a few/approval to test the 1 Micron.
- The filter change is a nominal cost and McBurnie gave approval to purchase 1-micron filters.

General Update on the water system.

• Safety item: Open hole outside a well, follow up with Bryan.

Financial Activities

- Suez contract from Dorinda Chacon of SUM, 2021 charge is \$18,508.94 from \$17,000.00 budgeted.
- Questions on SUM Monthly charges for February service: \$5,701.92,


