Surcharge	\$8.27

#### **Duration:**

The monthly surcharges will terminate upon reaching its specified end date, as outlined for each surcharge, or upon further order of the Commission, whichever occurs first.

**The Manager Services Surcharge** – A monthly service charge of \$14.50 per customer for the purpose of engaging the services of a manager for the operation of the water system and shall terminate in 24 months or upon collection of \$52,200, whichever occurs first.

**The Pipeline Project Surcharge** – A monthly surcharge of \$10.00 per customer for the purpose of the Lease Pipeline Project which shall terminate in 84 months or upon the collection of \$126,000, whichever occurs first.

**Surcharge** – A monthly surcharge of \$8.27 per customer shall terminate without further order of the Commission 12 months after the effective date of this decision unless terminated earlier in a future permanent rate case.

The above monthly surcharges are **in addition** to the current monthly rates and charges already in effect for the Company.
